## SUPERVISOR STATEMENT OF FINANCIAL AFFAIRS April 1, 2020 to March 31, 2021

For the fiscal year ended March 31, 2021, Moraine Township's Levy of \$1,350,000 was again frozen for existing taxpayers at the prior year's level. Reductions from the levy for property tax appeals and corrections resulted in total tax distributed to the Township of approximately \$1,334,000 during the fiscal year.

The Township maintains bank accounts for Town Fund, General Assistance Fund, and Community Chest. <a href="UNAUDITED">UNAUDITED</a> ending bank balances as of March 31, 2021 are as follows:

Town Fund

\$962,027

**General Assistance Fund** 

\$318,184

**Community Chest** 

\$224,323

Balances are **UNAUDITED**; the audit will begin in May, 2021.

State law permits funds to be transferred from the Town Fund to the General Assistance Fund; during the fiscal year, Town Fund transferred \$200,000 to the General Assistance Fund.

Moraine Township has no long-term or short-term debt.

## HIGHLIGHTS OF TOWNSHIP ACTIVITY DURING THE YEAR:

- The Township office and Food Pantry were closed to the staff and public in March of 2020 due to COVID-19. The Township purchased equipment and programs necessary to enable staff to work remotely.
- During the first few months, Township Staff remotely answered as many as 100 calls a day from the residents needing help, services, or resources.
- ➤ Staff and volunteers helped the Township deliver almost 35,000 unduplicated services during the 12-month period, including processing 124 applications for emergency rent and other assistance, and disbursing almost \$85,000, and almost 7,000 household visits to the Food Pantry.
- The Food Pantry immediately pivoted from shopping to drive-through with staff and volunteers working through heat, cold and snow to provide food to increasing numbers of residents. Volunteers and staff deliver to 35-50 households and seniors a week when clients are ill, sheltering in place, or work during Pantry hours.
- Thanks to our astoundingly generous community, contributions to the Township enabled us to purchase all food distributed over the last year when we were not able to accept food donations. Community contributions also funded almost \$65,000 of emergency rent and other assistance \$65,000 (of the total \$85,000 disbursed).
- Moraine Township applied for, and received, a \$15,000 grant for resident rent assistance through the CARES Act.
  In addition, the Township applied for, and received, a grant of \$77,319 from the CARES Act to cover the costs of equipment and IT to enable staff to work remotely, purchase PPE, install Plexiglas dividers, and implement HVAC retrofits to improve indoor air quality at the Township office and Food Pantry.
- ➤ The Door-to-Door Van Service was suspended for all but our residents needing Dialysis or chemotherapy treatments. Our heroic van drivers continued critical service for these residents. Thanks to a \$40,000 grant from the Healthcare Foundation of Highland Park we were able to keep the van service operating even with drastically reduced rider revenue.

While the last year has been an inconvenience for most of us, it has been a health and economic crisis for many of our neighbors. A big shout out to Moraine Township's army of volunteers and dedicated staff who made it possible for the Township to provide a safety net for residents without resources to navigate the pandemic.
