b. Approval of Summer Utility Assistance of \$250.00 per household

Assessor's Report: Assessor Lindsay

- a. Tax bills were mailed to residents; residents have been calling and coming into the office for clarification.
- b. As a reminder, residents with annual household income up to \$65,000.00, and who qualified for senior freeze in the past, and qualified but neglected to file in 2022, can apply for freeze to be retroactive to reduce the new tax bill.
- c. The Lake County Chief County Assessor has indicated that Moraine Township properties' assessed valuation will be increased by 10% in 2023.

Supervisor's Report: Supervisor Bassi

- a. A copy of the April Bank Balance Report was distributed to Trustees.
- b. A copy of the 15-month service report was distributed to Trustees.
- c. A copy of the Emergency Assistance Report for the current fiscal year was distributed to Trustees.
- d. The intergovernmental agreement between Moraine Township and the City of Highland Park regarding employee health insurance is in process.
- e. The credit card for Community Chest has been issued, with a \$10,000.00 limit.
- f. Revisions to the transportation policy were discussed.
- g. The Lake County Sheriff's Office will provide Active Shooter Training for staff and elected officials on May 10 at noon at the office.
- h. Trustees were invited to attend Township Officials of Illinois in-person educational conferences to be held over the summer.
- A discussion was held about the 2023 Regular Board Meeting Schedule. Meetings for June 27 and August 8 have been cancelled.
