

RESOLUTION OF THE MORAINE TOWNSHIP BOARD SETTING ELECTED OFFICIALS COMPENSATION

RESOLUTION NO. 10082020

WHEREAS, pursuant to Article VII, Section 9 of the Illinois Constitution of 1970, the compensation of an elected Township official may not be increased or decreased during the official's term of office; and

WHEREAS, the positions of Township Supervisor, Trustees, Assessor, and Clerk are elective positions within the meaning of Article VII, Section 9 of the Illinois Constitution of 1970; and

WHEREAS, the positions will be voted on at the Consolidated Election to be held on April 6, 2021; and

WHEREAS, the new term of office for the positions of Township Supervisor, Trustees, and Clerk are due to commence May 17, 2021, and a new term of office for the position of Township Assessor is due to commence on January 1, 2022; and

WHEREAS, said terms of office are for four (4) years duration; and

WHEREAS, the Township Board must establish the compensation of Township officers at least 180 days prior to the beginning of the term of office; and

WHEREAS, the Township Board must establish the compensation of Township Assessor at the same time the Township Board establishes the compensation of its Township Supervisor.

NOW, THEREFORE, BE IT HEREBY RESOLVED BY THE MORAINE TOWNSHIP BOARD as follows:

SECTION 1. The compensation of the elected officials of Moraine Township for the ensuing terms of office shall be as follows:

SECTION 2. Elected Township officials are not eligible for employee benefits.

SECTION 3. If any section, paragraph, or provision of this Resolution shall be held to be invalid, or unenforceable, for any reason, the invalidity or enforceability of such section, paragraph, or provision shall not effect of the remaining provisions of this Resolution.

SECTION 4. All previous Resolutions or parts of Resolution in conflict herewith are hereby repealed to the extent, and only to the extent they are in conflict, herewith.
