COVID-19 Mail-in Voting Expansions

Public Acts signed into law on June 16 implements changes to the November 3, 2020 vote-by-mail options include establishing an earlier date to start accepting applications to vote by mail, allowing applications to be submitted by email, and sending an Application for Ballot to voters who participated in any election since the November 2018 General Election.

Vote-by-mail avoids lines during early voting and on Election Day, and ensures social distancing!

Moraine Township 2020 Property Tax Assessment Notices Mailed August 4

Due to COVID-19, staff is available for REMOTE ASSISTANCE ONLY; call the Assessor's Office at 847-432-2100.

On August 4, 2020 Assessment Notices, (also known as the "Blue Letter") will be mailed to Moraine Township property owners, and published in the Highland Park News on August 4, 2020. Objections may only be filed online with the Lake County Board of Review no later than September 3, 2020. To file an appeal, visit https://www.lakecountyil.gov/551/Online-Appeal-Filing.

If you do not agree with the valuation of your property, you have <u>only thirty days from the date of publication</u> to file an appeal. The final date on which an objection to your 2020 Property Assessment can be filed is **September 3**, **2020**. Many people wait until they receive their property tax bill to try to challenge the assessment; unfortunately, that is too Late.

The Moraine Township Assessment office, or the County website, should be your first stop in understanding your 2020 assessment. Please call 847-432-2100.

Moraine Township Assessor's staff is available to help residents understand their assessment, answer questions on exemptions, and provide the resources residents need to evaluate their assessment and decide if filing an appeal is necessary. If warranted, Moraine Township Assessor may be able to make a change to your assessment without further appeal.

Challenges to assessments should be based on either

"fair market value" or "uniformity."

- If recent sales in your assessment neighborhood indicate that your parcel is overvalued compared with properties that have recently sold in your neighborhood, then that is a basis for an appeal.
- If your property or home is over-assessed compared to other similar properties or homes in your assessment neighborhood, this would also be a legitimate basis for an appeal.
- If you have a formal appraisal from a qualified appraiser, that could be a basis for an appeal.
- If you purchased your home in 2019 or 2020, check to see if the Assessor's value is more than your purchase price, and call to see if the Assessor can provide help.
