## **Make Use of Moraine Door-to-Door** Senior, Paratransit Mobility Needs Met by Township Vans

Moraine Township has been operating its own van service to meet the needs of residents since 2006. At that time, in response to unmet needs identified in collaboration with the Highland Park Senior Center, the original taxi fare budget of nearly \$100,000 (for travel limited to within Moraine) was revised to provide not only taxi subsidy but also more convenient paratransit transportation for seniors, disabled and financially needy residents who require travel outside Township boundaries to get to medical appointments in particular. The program was recognized by a statewide award for senior services.

Today, hundreds of residents take thousands of rides a year traveling tens of thousands of miles in the two "Moraine Door-to-Door" paratransit vans leased from Pace. With income-challenged riders generously underwritten in part by successive grants from the Healthcare Foundation of Highland Park, seniors, disabled and economically challenged residents and their caregivers ride for a single one-way fee of \$4. The vans travel up to a 15-mile radius outside Township borders, primarily to medical appointments.

If you know of a resident who would benefit from participation in our transportation services, advise them to call the dedicated phone line at (847) 432-3000 48 hours in advance of need to be scheduled for prompt, courteous service by our own drivers, weekdays from 8:30am to 4:00pm. All seniors are also entitled to 10 taxi coupons per month, worth \$3 towards rides anywhere within or outside Moraine Township, except to airports.

Moraine is part of the Lake County Coordinated Transportation Services Committee/LCCTSC, a group working to bring 24/7 reliable public paratransit to Lake County.

## **Citizen Grant Advisors Study Proposals Annual February 1 Deadline Provides Multiple Applications**

As we go to press, the hard-working Citizen Grant Advisory Committee is busy studying detailed proposals and budgets from 25 nonprofit organizations seeking public support for 29 programs on behalf of our residents. Grant proposals have been due at the Township on February 1 since FY06-07, with volunteers appointed to the Grant Advisory Committee spending the next two months reading, researching, discussing and making allocation recommendations to the Board of Trustees. Typically, their report goes to the Board at a late March meeting, and is voted upon at that time or the next meeting.

This year's group is again led by Chair Harry Crane. Members are Judy Datz, Wendi Ezgur, Matt Ferrari, Beth Olderman, and newcomer Mark Gilhooley. They are joined by Trustee liaisons Bryna Gamson and Jackie Schechter. For detailed information about the process and who has been granted funds in the past, consult the Township's website.

## SuperTalk: Mari Barnes

This issue of our newsletter highlights some of our activities over the past six months. It's exciting to see how much we're actually accomplishing, thanks to dedicated staff, Board and volunteers. I'd like to share a few of my thoughts in this area.

The strides we're making on becoming a nexus to achieve coordination of community-wide outreach efforts is a topic dear to my heart. Working towards a single effort in feeding the hungry and providing gifts to the needy, in order to focus



community help and target it to where it's really needed has been gaining real cooperation.

In a related topic, while addressing hunger we must also address nutritional needs and its relationship to community health. The Township is so pleased to have a new Pantry Plants Garden partner this coming summer: our neighbors at the Lake County Health Department's local clinic in Highland Park. In conjunction with discussions with our Latino Advisory Committee, clinic staff visited our Food Pantry to learn more about what we are providing. That we also attempt to supplement dried goods with fresh produce grown in our Pantry Plants Garden Project intrigued their staff. In fact, the Health Department started its first garden last year in North Chicago. Having excellent success there, they began looking into finding a site in Highland Park - and voilà! Their philosophy is similar to ours in that we both want to have residents come help us grow healthy vegetables that they can then take home and cook.

The Township has had a successful garden (located at Woodridge Park) due to a group of dedicated volunteers including Sam Piro, Fern Anderson, Barry Scholnick, and an NSSED student group under Steve Leverick's direction. Many thanks to all of them, to the Park District of Highland Park for donated space, and Anton's for donations of young plants. New workers will be welcome come the Spring thaw.... And we hope there will be a second garden site operating in Highwood.

Again looking at collaboration, I was pleased to help plan, organize and participate in *Options & Opportunities: Making Connections with Resource Providers Fair* initiated by State Senator Susan Garrett. Working together, along with other Township Supervisors, we were able to showcase the nature and breadth of human services available to our citizens. The Fair took place at Highland Park Country Club on November 15. Details were posted to our website on the news pages. Participants seemed highly pleased.

We've strengthened our ties to the Nuestro Center, a highly successful project of Family Service, providing programs, resources and information to our Latino neighbors. The Board voted a capital, one-time contribution of \$50,000 to assist with build-out expenses when they finalize their planned move to new quarters in Highwood. There, it is expected they will be able to expand their activities to address health issues and more concerning not only the young people but also families—seniors in particular—in the community. The former location was limited to serving residents of the old North Shore Estates apartments; the new Center will concentrate on the population whose children attend Oak Terrace School.

Speaking of donations to underwrite important community services, we look forward to the recommendations of our Citizen Grant Advisory Committee, currently hard at work on reading proposals for annual grants. At the same time, the Board has begun the process of adopting a

## CommunityTalk: Speaking of Green

#### **Green Schoolyards Program**

Moraine hosted a free, well-attended program in cooperation with the Highland Park Public Library and Districts 112 and 113 to inform and stimulate residents eager to literally change the local environmental landscape. Highland Park-reared environmental planner Sharon Danks and colleague Rachel Pringle presented *Creating & Sustaining Green Schoolyards* on October 14 at the Library. The northern California-based women are each a newly published author of cutting-edge books with ideas for community implementation of replacing asphalt play areas with creative natural elements that provide recreation, education and even nutrition while improving local ecology.

#### **Recycling Bulky Polystyrene Packing Material**

Lake County Board member Anne Flanigan Bassi and Moraine Township facilitated local efforts to reduce the problem of bulky polystyrene foam (known by its trademarked name Styrofoam) by enlisting Abt Electronics to provide a trailer to collect these items and more on October 23. Abt generously hauled them to their Glenview store's recycling facility. The Park District of Highland Park provided their parking lot at Hidden Creek AquaPark for drop-off. Although the Township, Park District, Abt and Bassi volunteers were prepared to repeat the event periodically, happily, the City of Highland Park has fulfilled an ambition to recycle bulky plastic foam; they have begun to provide a twice-weekly opportunity for residents to drop it off for recycling along with old electronics on Half Day Road just east of Route 41.

I am so pleased to report here that free transit fares to seniors irrespective of financial means is a thing of the past: Governor Quinn finally signed the measure to rescind it in February. The new law restores the old system of half-fares for all seniors; Circuit Breaker qualification will be used as a means test for those who actually need free fares. The RTA has up to six months to implement the new system, so in the meantime, those who have the "smart card" pass should continue to use it, and watch their mail for instructions under the new law.

## **Latino Advisory Committee Update**

Volunteer members of the Moraine Township Latino Advisory Committee have been actively meeting over the past year, and their feedback has been very productive on behalf of our constituents.

One goal of the Board in establishing an advisory committee was to improve two-way communication between the Township and residents we serve. Members of the Latino Advisory are ombudsmen to our Spanish-speaking neighbors, seeking to open channels of communication and bringing to the Board's attention gaps in information or services that might be improved through Township intervention. The Board also wishes to foster further grassroots government participation by establishing a welcoming atmosphere.

Members have volunteered to assist at emergencies requiring bilingual speakers. Some are also serving on other committees tied to the Latino community, thus networking and adding informed insight. Among achievements this year to increase awareness and comfort with Moraine Township was their distribution of a Spanish-language translation (accomplished by staff member Grizell Toledo) of the Township's basic handout describing services; the handout is also put into client Food Pantry bags as appropriate. Advisors also worked to encourage resident Latino turnout at the Highwood Great Pumpkin Fest, with satisfying results; Supervisor Barnes arranged for a table for carving pumpkins and others volunteered at the event. Our Food Pantry was also a continuing topic of conversation, and outreach efforts to improve nutritional habits in the community have begun.

Chair Paul Martinez reported at the Board meeting of December 16 (Minutes are online) that the advisors met with personnel from the Lake County Health Department's Highland Park clinic. Their eagerness to work with residents to improve overall eating habits and health dovetails neatly with the Supervisor's enthusiasm for the Pantry Plants Garden Project, and projects undertaken at Family Service's Nuestro Center. Plans are being made to further educate residents on applying healthy food portions to the Latino diet in particular. Diabetes and obesity prevention, and the importance of exercising for health benefits, were presented as well. Synergy is at work as the various agencies coordinate and collaborate on this topic; Moraine will be cooperating to promote resident health.

At their January meeting, financial literacy challenges within the Latino community were discussed. As follow-up, plans are underway to facilitate a program to educate interested residents in financial literacy, and to explore ways to coordinate volunteers for tax return preparation assistance.

In addition to Paul Martinez, members of the Latino Advisory Committee appointed by the Supervisor include Rosemary Espinosa, Michelle Flores, and Wendy Lerrick. Among others actively attending meetings are Gregorio Resendiz (from Family Service) and Lori Flores Weisskopf. Board liaisons are Trustees Dwayne Douglas and Margoth Moreno.

## ClerkTalk: Ellen Gussin Plan Ahead for April 5 Election

The April 5 Consolidated Election should draw a large voter turnout from those of us wanting to exercise our civic responsibility. The City of Highland Park will elect a new Mayor as well as three new members for City Council seats. Both School Districts 113 and 112 will elect new School Board members. The Park District of Highland Park will be electing new members. The City of Highwood will be electing a Treasurer and four

Aldermen, and there are candidates for College of Lake County Board and for Trustees of the Regional Board of Schools. In addition, there will be a tax referendum from District 113 on the ballot. (Go to their website at http://dist113.org for information.)

Attend the League of Women Voters' *Meet, Hear and Question the Candidates* event on March 6, from 12:30-5:30pm, at the Highland Park Country Club. Making up your mind may be difficult, but the process of voting has never been easier, nor with as many options.

#### **Voter Services Thrive in Moraine Township**

Early Voting and Voting by Mail continue to be popular options for Moraine Township residents. Because of the great number of voters casting their vote prior to Election Day, the number of polling sites has been reduced, yielding greater efficiency and cost savings. Locations for Early Voting for each of the four municipalities in Moraine Township are also noted on the Township's website via Clerk page.

#### **Early Voting Begins 22 Days Before Election Day**

Early voting is offered to any registered voter and begins 22 days before Election Day. Early voters are required to present to voting officials a valid Illinois driver's license, an Illinois identification card issued by the Secretary of State, or any other valid government-issued identification document containing their photograph and name. In Moraine Township, Early Voting takes place at the Lake County North Shore Health Center at 1840 Green Bay Road in Highland Park. It will begin on March 14 and end on March 31 for the April 5, 2011 Consolidated Election.

#### Voting By Mail - And NEW "Permanent" Vote By Mail

Illinois law now permits any registered voter to receive a ballot by mail. One-time requests for a ballot can be made via a form provided online at the County Clerk's website; by email at VotingByMail@lakecountyil.gov; or by calling (847) 377-2406. Voting by mail will begin on March 11 for the April 5, 2011 Consolidated Election.

For voters who prefer to vote from home, the Lake County Clerk's office offers a new permanent voting by mail program. I've used it myself and find it extraordinarily easy and helpful. Enrollment forms are available online at the County Clerk's website. Permanent voting by mail helps reduce printing costs. As required by state law, voting by mail requests cannot be processed until 40 days prior to each Election Day. Ballots cannot be mailed any later than the Thursday before an election. Please note: voters requesting a ballot prior to Election Day are not entitled to cast a ballot on Election Day.

#### **Snowbird Program**

Voters who travel seasonally can enroll in the Snowbird Program and specify elections and an alternate address to which a ballot should be mailed. Those enrolled will automatically receive a ballot by mail as specified.

#### **Student Program**

The Temporarily Absent Student Program is available to students away at school. A student must be a registered voter in order to enroll in the program. Use the County's fillable online enrollment form which can be printed, signed and mailed to the County. Enrollment is valid for two years and each summer the County office confirms the student address for the coming year away at school.

#### **Voter Registration**

Voter Registration is available Monday through Friday at the Moraine Township Office during regular business hours of 8:30am to 4:30pm. To register to vote, bring two forms of identification—one with your name and current address. You must be a United States citizen, 18 years old by the next election (a 17-year-old can register as long as his/her birthday is on or before the date of the next election) and have resided in the voting precinct for 30 days prior to the next election.

The voter identification card is your official source document for determining where to vote. Your polling place is determined by your precinct number and is listed on your voter registration card. Polling place locations, addresses, as well as maps, are also available online.

Voter Registration ends on March 8 in order to be eligible to vote in the April 5 Election.

## What's The Assessor Got To Do With Township Government?

As the Northwest Territory was opened up in the 19th Century, surveyors were sent to lay out counties, divided into townships, as a means of noting natural features, and establishing property boundaries. To this day, real estate legally bears historic descriptions such as Moraine's township number (43 North), subdivided by a standard 6 square-mile grid overlay (having internal Sections, numbered 1-36), divided into acreage within them (640 acres per Section). Interestingly, to stick to this grid despite irregularities in nature, in fact, some of our Sections are "in the lake."

Early settlers worked together to solve community problems like caring for the sick and needy, and building roads and schools. Ultimately, to share the financial burden fairly, each according to his ability to contribute, a system of property assessment was established. Over time, many township functions were absorbed by growing municipalities, but in many areas of Illinois, townships still directly provide human services, road maintenance and even recreation programs.

In Moraine Township, property is appraised in value as objectively as possible so that each provides a fair share to the taxing bodies whose rates are applied to the valuation. The Moraine Assessor calculates the value of the property; the Lake County Assessor applies an equalizer; and the County collects the taxes on behalf of all regional taxing bodies, including relevant city/city services, schools, Lake County operations and entities like Moraine Township government itself.

## **AssessorTalk: Patty Powers**

Having completed my first year of Township Assessor, I would like to say what a rewarding experience it has been. I have attended many meetings throughout the year both at the Township and County levels and have met many interesting people. I am grateful to all who have shared their knowledge and ideas with me. The transition to Assessor from Deputy Assessor went smoothly, mainly because of my staff here in the office. Each staff member has completed their C.I.A.O. (Certified Illinois Assessing Officer) designation, and I'm very



proud to report the positive feed back from taxpayers on how helpful and knowledgeable the office staff has been. They are happy to help during the appeal period and throughout the year with questions about exemptions, property record cards, the assessing process, etc.

As many of you know, the job of the Assessor is not to tax but to apportion the tax burden fairly and equitably throughout the Township. We have heard over and over again "I don't mind paying my taxes as long as I'm just paying my fair share." Assessors realize how personal property taxes are, and we do our best with the actual sales data we have, to ensure fair and equitable assessments. To make sure you are being assessed correctly, I again encourage you to review your own property record card to check for accuracy.

This past year, we have seen fewer new homes being constructed; however we are still receiving many permits for upgrades and additions. In recent years, the Township has had 143 "unqualified" sales (any sale that is not an arm's length transaction, such as foreclosures, short sales, sale between related individuals, court ordered sale, auction sale): in 2008 - 44, in 2009 - 53 and known to date for 2010 - 46. The majority of the 143 sales were foreclosures.

2011 is our general reassessment year, which means we will be looking at changes to assessments. The only change the majority of homeowners saw in 2008, 2009 and 2010 was the equalization factor applied at the County level. We may see land value changes, neighborhood boundary changes, and other factors that affect total assessments.

To determine values for 2011, we must still follow the law that states we use the three previous years of sales, which means we will be looking at sales that occurred in 2008, 2009 and 2010. Though you won't receive your assessment notice until August or September of 2011, our books are based on sales that have occurred prior to January 1st of 2011.

Here's a reminder for Township residents celebrating their 65th birthday this year: apply for the Senior Exemptions you may qualify for. These include a Senior Homestead Exemption in the amount of \$4,000 deducted from the equalized assessment valuation for all seniors. For those who further qualify for the Senior Freeze Homestead Exemption, which is based on a total household income of \$55,000 or less, an exemption freezes your assessment not your taxes. The Senior Freeze Homestead Exemption must be renewed annually. To qualify for any of these exemptions, you must have lived on the property which is your principal residence on or before January 1 of the tax year, and have reached age 65 during the tax year; otherwise, the value may be prorated for the portion of the year that it was owner-occupied by a senior citizen.

You can apply for exemptions at the Township Assessor's Office at 777 Central, Highland Park. For more detailed information, consult our website, stop in and talk to us or phone (847) 432-2100.

## **Food Pantry News**

Residents often step forward when solicited during formal food drives like that from the Postal Workers in Spring, or at holiday times during December. In between, we often find generous donations of foodstuffs or funds to help us help our neighbors. As a member of the Northern Illinois Food Bank, the Township also regularly purchases meats and supplementary foods. The Food Pantry is open twice weekly on Tuesdays and Thursdays, when regular users know to come pick up bags made up for them by Township staff and volunteers. At times of emergencies, of course, food can be and is made available for the needy, but clients know to plan ahead for their shopping days at our office. We urge motivated residents to donate only food they would consume themselves: unexpired canned and boxed goods. And consider volunteering!

## **Talk About Help**

- The Township website has links to many helpful resources, provided by agencies we support with grants, and links to county, state and federal program information.
- We suggest that every resident—particularly elderly or those who live alone—prepare a clearly written list of whom they want called if there is an emergency. Put it on the refrigerator in a prominent spot and file a copy with the Township and local police department.
- Obtain smoke and carbon monoxide detectors via Moraine Township. We pay for First Alert for qualifying residents. Contact GA/EA Manager Paula Peddle.
- Make use of our transportation options: Moraine provides seniors with 10 taxi coupons per month, worth \$3 each off of taxi rides anywhere except airport as well as the Moraine Door-to-Door paratransit van rides for \$4 each way. See our article on page 1 for details on qualifications. Call our dedicated Van line at (847) 432-3000 48 hours ahead to reserve a seat.
- Enroll for an RTA pass at the Township Office. No charge for residents. \$5 fee for non-residents. We take your photo and submit your application to the RTA. Plan ahead for use. Persons 65 and older, disabled and income-qualified under Circuit Breaker standards may apply for an RTA reduced or free fare pass.
- Our General Assistance Manager Paula Peddle is always happy to provide a guiding hand into information about human service assistance. Do not hesitate to inquire when life circumstances change and you aren't sure where to go for help.
- Make use of our Food Pantry. We're here to help residents through hard times.
